Notes:

- Out of the total 3,90,61,392 partly paid-up shares shown above in column V, the Company has received first and final call money on 5,87,323 shares and accordingly has obtained listing permission for the same from Stock Exchanges. However since these shares could not be credited to the demat account of respective allottees due to technical rejections, these are still reflected under the partly paid ISIN in the records of the Depositories.
- As on September 30, 2023, the paid-up equity share capital of the Company comprises of 1357,42,14,153 fully paid-up equity shares having a face value of Rs.2/- each bearing ISIN INE040H01021 and 3,84,74,069 partly paid-up equity shares having a face value of Rs.2/- each with Re.1/- paid-up bearing ISIN IN9040H01011. The paid-up capital as on September 30, 2023 includes 5,87,323 shares as fully paid up since call money has been paid on these shares.
- The voting rights are considered in proportion to the amount paid-up on the face value of the shares, i.e. Fully paid-up shares x Rs.2 and Partly paid-up shares x Re.1. Accordingly in column IX of Table I, II and III, fully paid-up shares are considered as having one voting right whereas partly paid-up shares are considered as having half voting right.

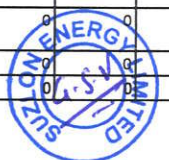

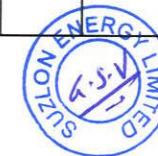
