- (2) As on June 30, 2023, the paid-up equity share capital of the Company comprises of 1240,90,37,097 fully paid-up equity shares having a face value of Rs.2/- each bearing ISIN INE040H01021 and 6,40,49,986 partly paid-up equity shares having a face value of Rs.2/- each with Re.1/- paid-up bearing ISIN IN9040H01011. The paid-up capital as on June 30, 2023 includes 31,80,992 shares as fully paid up since call money has been paid on these shares.
- (3) The voting rights are considered in proportion to the amount paid-up on the face value of the shares, i.e. Fully paid-up shares x Rs.2 and Partly paid-up shares x Re.1. Accordingly in column IX of Table I, II and III, fully paid-up shares are considered as having one voting right whereas partly paid-up shares are considered as having half voting right.

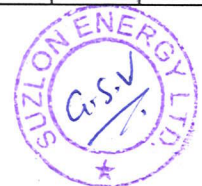
