Suzlon Group crosses historic 1 GW milestone in UK

Hamburg/Edinburgh: Suzlon Group subsidiary REpower Systems, a leading manufacturer of onshore and offshore wind turbines, has reached the historic milestone of 1 gigawatt (GW) installed capacity across UK wind farms.
