This is to inform that in terms of Share Subscription and Shareholders' Agreement executed by the Company and Ostro Energy Private Limited ("Ostro"), a wholly owned subsidiary of ReNew Power Services Private Limited ("ReNew"), with (a) Shreyas Solarfarms Limited ("Shreyas"); and (b) Aalok Solafarms Limited ("Aalok"), the subsidiaries of the Company, the Company has initiated sale of securities of Shreyas and Aalok to Ostro and accordingly Shreyas and Aalok have ceased to be the subsidiaries of the Company. Consideration received from such sale / disposal	The Company has received an aggregate consideration of Rs.10.13 Crores on sale of 26% of its existing stake in Shreyas and the balance stake would be transferred on receiving the balance consideration of Rs.9.74 Crores, which is proposed to be completed in due course.
	The Company has received an aggregate consideration of Rs.5.06 Crores on sale of 26% of its existing stake in Aalok and the balance stake would be transferred on receiving the balance consideration of Rs.4.87 Crores, which is proposed to be completed in due course.
	While Shreyas and Aalok have ceased to be the subsidiaries of the Company, post the transfer of balance stake, which is proposed to be completed in due course, Shreyas and Aalok would become wholly owned subsidiaries of Ostro.
