*Note 1- Out of net proceeds disclosed in the offer document, a total of Rs 900 crore was utilized towards repayment of borrowings availed by the Company: Rs. 583.5 crore during the quarter ended December 31, 2022, Rs 316.5 crore during the quarter ended March 31, 2023.

*Note 2- Rs. 5.52 crore was received by the Company during the quarter ended December 31, 2023, out of which Rs. 1.08 crore was towards Rights Issue Final call against which allotment of fully paid shares was done by the Company. The balance of Rs. 4.43 crore was the amount of interest received due to delay in payments by shareholders or excess received against which no allotment was required. The Company has passed resolutions at the meetings of the Securities Issues Committee of Board of Directors of Suzlon on October 11, 2023, November 24, 2023, and December 15, 2023, for aggregate amount received towards Rights Issue Proceeds during the quarter ended December 31, 2023, and approved conversion of partly paid-up shares to fully paid-up shares.

*Out of Rs 1.08 crore, Rs 0.5 crore were transferred for operational ease from the Company's Right Issue Allotment Account to the Company's IndusInd overdraft account for utilisation towards GCP and parking funds temporarily in fixed deposits. Total proceeds available for utilization for the quarter was Rs 35.42 crore, out of which Rs 34.84 crore was utilized towards GCP and balance of Rs 0.58 crore is lying in rights Allotment account. The figures are rounded off to the second decimal.

Note 3- For the Balance Call Money of Rs. 8.54 crore, the Company plans to send further reminder notices in Q4 FY24. The figures are rounded off to the second decimal.
