Suzlon successfully completes commissioning of 340 MW solar projects

- Projects commissioned on turnkey basis across Telangana, Rajasthan and Maharashtra

The projects have been executed over a period of time, concluding in Q4 FY18.

With the commissioning of the 340 MW Suzlon has completed delivery of its entire solar order book. The projects have been executed by combination of joint ventures or formation of Special Purpose vehicles (SPVs) with various partners.
