Suzlon Group announces new appointments for REpower Executive Board and Management Board

- Lars Rytter assumed COO role on 1 August
- Russell Stoddart starts as CTO on 12 August
- New Management Board of REpower Systems GmbH set up

Pune/Hamburg: As of 1 August, Lars Rytter has taken over as Chief Operating Officer at REpower. In his new role, Rytter will be able to make an important contribution to REpower's programme for the future. With this programme, the Company's plans include realizing significant savings in the areas of purchasing, production and manufacturing.
